## INCOME AND RENT CALCULATION (PH AND HCV) COURSE NO. 100.9

### SUMMARY

This course, for both PH and HCV, provides the framework for determining Annual Income, Adjusted Income, Total Tenant Payment (TTP), Tenant Rent, and the Housing Assistance Payment (HAP) and Rent to Owner. Core class for certification programs (with 100.7 or 100.8).
