- Any information or policies related to resident employment or resident councils
- Notices of Board Meetings (must be on window, door or other place visible to public)
- ▶ Office Hours (must be on window, door or other place visible to public)
- ▶ Notices of changes or other items affecting tenant lease (post for 30 days)
- ▶ PHAS (Public Housing Assessment System) Scores
